Dear Secretary Warner:

Please place within the Orders File of the State Register the attached Order and Fee Schedule revising the licensure fees for health care facilities licensed by the West Virginia Department of Health and Human Resources.

The health facility licensure fees will be increased by 1.36 percent, which is the rate of growth to the Consumer Price Index over a period of 12 months from January 1, 2020, to December 31, 2020, pursuant to the following authorities:

Hospitals and Similar Institutions, W. Va. Code §16-5B-4;
Nursing Homes, W. Va. Code §16-5C-6(e);
Assisted Living Residences, W. Va. Code §16-5D-6(i);
Residential Care Communities, W. Va. Code §16-5N-6(e);
Chronic Pain Management Clinics, W. Va. Code R. §69-8-4.4.1.;
Medication-Assisted Treatment/Opioid Treatment Programs, W. Va. Code R. §69-11-6.3.a.; and
Medication-Assisted Treatment/Office-Based MAT, W. Va. Code R. §69-12-6.3.a.

The new licensure fees will become effective: June 1, 2021.
